Public Housing

- Property owned and managed by a local public housing agency
- Apply with public housing agency
- Rent is income-based

Project Based Voucher

- Privately-owned and managed
- Subsidy is tied to the unit
- Apply with specific property
- Rent is income-based



Section 8 Voucher

- Administered by a local public housing agency
- Vouchers are applied to units in the private market
- Subsidy is tied to the tenant
- Apply with local Public Housing Agency
